# Materials

The Sweden & Martina dental implants are made of commercially pure medical titanium grade 4 (ASTM F-67) because scientific research has shown that this metal is biocompatible with human tissues, which is a critical factor for determining bone integration.

The company's commitment in the search for the highest quality raw materials, certificate of origin, allows your dentist to always choose the best option for your clinical needs.

# Care and Maintenance Instructions

The duration of implant rehabilitation is subjective, but also depends on the patient's good oral hygiene. This is confirmed during the follow-ups, which allow immediately evaluating the onset of any peri-implantitis.

We recommend you always follow the directions and the pre- and post-operative instructions of your implant expert and contact him if you have doubts on how to clean and care for your implant.

# Certification of Quality

This Dental Card certifies that the implants and prosthetic components used for your implant-supported prosthetic solutions are original, that their quality and technology complies with the ISO 9001 and ISO 13485 standards and that they carry the CE marking in accordance with Regulation (EU) 2017/745.

Starting from 26<sup>th</sup> May 2021 it's compulsory for the doctor to fill the Dental Card with the following information:

1. Patient name or patient ID
2. Name and address of the health institution that placed the implant
3. Date of the implant placement

The label for patient use, available in the implant case must be attached on the dental card.

The label for patient use, available in the prosthesis packaging must be attached on the dental card.

We have met the good manufacturing standards (GMP) set forth by many countries worldwide, including the United States FDA. This Dental Card will allow any dentist to recognise your implant and intervene accordingly.
